“RESOLUTION ENACTING ORDINANCE NO. 04, SERIES OF 2012, ENTITLED, “AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NO. 02-5TH SP, SERIES OF 2011, ENTITLED, “AN ORDINANCE REQUIRING ALL PREGNANT WOMEN IN THE CITY OF TACURONG TO GIVE BIRTH AT THE BIRTHING CLINIC, RURAL HEALTH UNIT, BARANGAY HEALTH STATION AND HOSPITAL.”

Presented to the body by Honorable Paredes for information and appropriate action is the letter of Dr. Giovanni D. Deles, M.D., City Health Officer, requesting for an amendment of Section 5 of Ordinance No. 02-5th SP, series of 2011, entitled, “An Ordinance Requiring All Pregnant Women in the City of Tacurong to Give Birth at the Birthing Clinic, Rural Health Unit, Barangay Health Station and Hospital”;

WHEREFORE on motion of Honorable Paredes, which was duly seconded by Honorable Cajandig, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, to enact as it hereby enacts

Be it ordained, by the Sangguniang Panlungsod of the City of Tacurong in session assembled, that :

SECTION 1. Section 5 of Ordinance No. 02-5th SP, series of 2011, which reads as follows:
