**EXECUTIVE ORDER NO. 42**

Series of 2020

**AN EXECUTIVE ORDER ORDERING THE ISOLATION OF FOUR (4) PERSONS IDENTIFIED BY THE CITY HEALTH OFFICE FOR 14 DAYS MANDATORY QUARANTINE IN LGU TACURONG ISOLATION FACILITY FROM SEPTEMBER 28, 2020 TO OCTOBER 11, 2020 WHO WERE FOUND REACTIVE TO RAPID TEST TO CORONA VIRUS AND THE TEMPORARY CLOSURE (LOCKDOWN) OF THE RESPECTIVE "TALIPAPA" SITUATED IN BARANGAYS SAN PABLO, BUENAFLOR, POBLACION, NEW LAGAO ALL IN TACURONG CITY FOR SEVEN (7) DAYS FOR DISINFECTION PURPOSES STARTING SEPTEMBER 29, 2020 TO OCTOBER 5, 2020**

WHEREAS; a report from the City Health Office and the PNP Station Tacurong City was received with the information that four persons who are selling goods in "talipapa" situated in Barangays of San Pablo, Buenaflor, Poblacion, New Lagao, Tacurong City which are particularly described in the following locations: (1) Sariling Atin Housing, Purok Summer Snow, Buenaflor, (2) National Highway corner Barangay San Pablo Road, San Pablo, (3) Alunan Highway (in front of a LPG retailer), Poblacion, (4) Brgy Road, Purok Paghidaet (along the house of a former Brgy. Official), New Lagao, City of Tacurong were found reactive to rapid test to corona virus;

WHEREAS; that the four persons were considered Suspects for COVID 19 and should be restricted or confined in the LGU Isolation Facility;

WHEREAS; pursuant to DILG Regional Memorandum Order No. 2020-14 and stipulated under Executive Order No. 112 and NTF Memorandum Circular No.2 there is a need to isolate the subject persons and temporary close their "talipapa" for disinfection, prevention, and precautionary purposes,

WHEREAS; Executive Order 49, Series of 2020 of the Province of Sultan Kudarat Extending the Implementation of MGCQ in the Province of Sultan Kudarat in Section 32 thereof, the Local Chief Executive is given the authority to declare granular lockdown to prevent and impede the spread or contamination thereof;

NOW, THEREFORE, I ANGELO O. MONTILLA, by the powers vested in me by law as the City Mayor of Tacurong City do hereby issue an Executive Order ordering the Isolation of Four (4) Persons Identified by The City Health Office for 14 Days Mandatory Quarantine in LGU Tacurong Isolation Facility from September 28, 2020 to October 11, 2020 who were Found Reactive to Rapid Test to Corona Virus and the Temporary Closure (Lockdown) of The Respective "Talipapa" Situated in Barangays San Pablo, Buenaflor, Poblacion, New Lagao all in Tacurong City for Seven (7) Days for Disinfection Purposes Starting September 29, 2020 to October 5, 2020

1. The following "talipapas" situated in Barangays of New Carmen, San Pablo, Poblacion, New Isabela, all in Tacurong City which are particularly described in the following locations shall be temporarily closed for business for seven (7) days for disinfection purposes starting September 29, 2020 to October 5, 2020:


- Sariling Atin Housing, Purok Summer Snow, Buenaflor (1 talipapa)
- National Highway corner Barangay San Pablo Road, San Pablo (1 talipapa)
- Alunan Highway (in front of a LPG retailer), Poblacion (1 talipapa)
- Brgy Road, Purok Paghidaet (along the house of a former Brgy. Official), New Lagao (1 talipapa)

2. The City Epidemiology Surveillance Unit (CESU) in partnership with the PNP Station of Tacurong City shall conduct comprehensive case investigation within 24 hours and contact tracing of all close contacts of persons who were found reactive to rapid test to corona virus and shall render a daily report inclosing his monitoring and evaluation of the status of the spread or contamination of the Corona Virus in the identified areas, for its submission thereafter to the DILG Regional Director/RIATF 12 Chairperson.
3. The BHERTS of Barangays Buenaflor, San Pablo, New New Lagao and Poblacion are hereby directed to conduct daily monitoring of direct contacts the subject persons and render a daily report to the CESU.
4. The Sanitation Group (CENRO) of the Incident Management Team (IMT) is directed to conduct disinfection activity on the aforementioned "talipapas" and its surrounding premises within 24 hours upon issuance of this order, during the period of temporary closure and before resumption of business.
5. The City Health Office shall ensure that all persons involved in the operation of the subject "talipapas" shall present a negative rapid test result (at their own expense) before resuming operation.

Let a copy of this Executive Order with Data Analytics and Action Plan including the report of the City Health Officer and PNP Station of Tacurong be submitted to RIATF – EID Region 12 in compliance with DILG Region 12 Advisory dated August 24, 2020 for concurrence purposes and copy furnished the DILG Provincial Director of the Province of Sultan Kudarat.
