

EXECUTIVE ORDER NO. 18

AN EXECUTIVE ORDER LIFTING THE ENHANCE COMMUNITY QUARANTINE (ECQ) STATUS OF FOUR HOUSES IDENTIFIED BY THE CITY HEALTH OFFICE LOCATED IN BARANGAYS NEW ISABELA, NEW CARMEN AND BARAS, CITY OF TACURONG AS PER ZONING CONTAINMENT STRATEGY

WHEREAS, the City Epidemiology and Surveillance Unit (CESU) of the City Health Office of Tacurong City recommended the lifting of the Enhance Community Quarantine (ECQ) status of a house in Purok Salukag, New Carmen; two houses located in Puroks Sampaguita and Rosal, Barangay New Isabela, and a house in Purok Summersnow, Baras, City of Tacurong which was previously declared as Critical Zone as per Zoning Containment Strategy under Executive Orders No. 08, 03, and 07 respectively.

WHEREAS, the residents of the houses mentioned above had already completed their mandatory quarantine period required by the Department of Health (DOH) and Inter Agency Task Force (IATF) as per report of the CESU.

WHEREAS, pursuant to DILG Regional Memorandum Order No. 2020-14 and stipulated under Executive Order No. 112 and NTF Memorandum Circular No.2 there is a need to implement a localized lockdown and strategically contain the spread or transmission of the said virus;

WHEREAS, Executive Order 61, dated January 1, 2021 of the Province of Sultan Kudarat particularly Section 33 thereof, the Local Chief Executive is given the authority to declare granular lockdown to prevent and impede the spread or contamination thereof;


NOW, THEREFORE, I ANGELO O. MONTILLA, by the powers vested in me by law as the City Mayor of Tacurong City do hereby Order the following:

SECTION 1. HOUSES UNDER ECQ LIFTED. The residents of the subject houses identified by the City Health Office shall now be allowed to go outside of their residences. However, those persons previously found to be positive of COVID 19 shall closely coordinate with their BHERTS and CESU for further guidance and instructions.

SECTION 2. EFFECTIVITY. This Order shall take effect immediately.

Let a copy of this Executive Order submitted to RIATF – EID Region 12 in compliance with DILG Region 12 Advisory dated August 24, 2020 for concurrence purposes and copy furnished the DILG Provincial Director of the Province of Sultan Kudarat and Office of the Provincial Governor of the Province of Sultan Kudarat.
